1. Call to Order-

Chairman Shane Croker called to order the meeting at 6:32 p.m.

5. Approve the Minutes of March 3, 2015-

Chairman Shane Croker opened the public hearing at 7:07 p.m. Mark Edgren, Huffines Communities, spoke to the Commission regarding the preliminary plats stating that there is a combined total of 270 lots and

Heartland is seeking approval for preliminary plats. Mr. Edgren explained that the minimum lot size is 40' foot lots, with lot sizes that include 40,50 and 60 foot lots. Mr. Edgren explained that the builders are proposing housing with different floor plans and diversity. The public hearing was closed at 7:22 p.m.

Michelle Barton made a motion to recommend denial of approval of the plats to the City Council. Sharon Russell seconds the motion. The motion carried with Shane Croker voting against the motion.
